If signing for a *2 year contract, activation, installation and training are free for up to 3 receivers at the time of installation. **If no contract: Activation Fee is \$250.00 which includes: 100% of activation, installation and training for up to 3 receivers.** Additional Receivers can be set up at the time of initial activation at an additional charge of \$60.00 per run. After the initial activation, any work, wiring or maintenance done at the customer premise will be billed at: \$60.00 per hour labor, material and wiring charges, along with a \$50.00 service call charge. If disconnected prior to fulfilling contract a \$250.00 fee will be incurred.
